 - o Area next to the Playground This project is postponed. Not a good time to plant grass. Karen and Dave will talk mid-August about possibly doing the project in fall.
 - o Signage Karen gave 2 examples of signage for the beach gate. She will put the order in for a new sign on the front of the gate and on the back side. All agreed that the existing signs on the gate can be removed.
 - o Boat Ramp Removal / Shore Friendly We have an initial report from Shore Friendly that describes the ecology of the beach. Next step is to get a detailed geologic assessment. Cost is about \$7,000, which JBE would pay for and then get reimbursed by Shore Friendly. Karen proposed that we proceed with the detailed assessment with confirmation that we will get reimbursed cost.

Project	Status
Pier cleaning	Carl, Everett and I looked at the pier and decided to wait on power-washing.
Bent railing at beach	Karen has been trying to connect with Dave Brown about whether he will help us fix it. If he doesn't reply to today's email I will knock on his door.
Additional help for Carl	Karen contacted JBE resident Raul Turrieta, as he has posted on FB about wanting yard work. He is not interested in working hourly unless we pay \$30/hr. He may be interested in working projects for a fixed price.
Area next to playground	At this point we should postpone this project until fall. Karen's calendar is full and mid-summer is not a good time to plant grass since it would require daily watering for a couple of weeks.
Signage	PRIVATE PROPERTY NO TRESPASSING DO NOT ENTER WITHOUT A GATE KEY If we want to keep the beach rules sign, it needs to be located at the beach. On the gate itself, any signage needs to focus on preventing people from driving down without a key and preventing non-JBE residents from entering at all.
Boat ramp removal / Shore Friendly	We have the initial report from Shore Friendly that describes the ecology of our beach and the possibility of removing the old boat ramp. The next step in the process is to get a detailed geologic assessment, which costs ~\$7,000. This sets us up for the real work of getting bids from contractors and applying for grants to help fund the project. We also received a template for the Shore Friendly contract. Basically how it works is we pay for the work and get reimbursed for up to \$14,000. Shore
	Friendly grant money is the source of the reimbursement. I will propose we move forward since it doesn't cost us anything (once we're reimbursed) and this is the best path forward in terms of restoring the beach on the northwest side of the pier. If we do nothing then the access to the

	beach will eventually erode to the point where it's unsafe and we'll have to block it off.
New toxic plant	Poison hemlock is showing up more around here. It looks like Queen Anne's Lace, which is not toxic. Poison hemlock is very toxic (both topically and ingested) so we should keep an eye out for it.
